Right onto OH-747 / Princeton Glendale Rd. go 1 mile.
Pass Smith Road and Krogers.

Turn Right at the light into Beckett Commons Complex in front of Arby's and follow road to left away from Steinmart. We are in the CMC building at the far north of the parking lot. Go to the second floor, turn right at top of the stairs. Suite 210.

From Tylersville Rd.:

Turn South on to OH-747/Princeton Glendale Rd. toward Tri-County
At the first light you will turn left into Beckett Commons Complex in front of Arby's and follow road to left away from Steinmart. We are in the CMC building at the far north of the parking lot. Go to the second floor, turn right at top of the stairs. Suite 210.

From I-275:

Take Exit #42 OH-747 Springdale Glendale
Go North on OH-747/ Princeton Glendale Rd. for approx. 4 miles.
Pass Smith Road and Krogers.

Turn Right at the light into Beckett Commons Complex in front of Arby's and follow road to left away from Stein Mart. We are in the CMC building at the far north of the parking lot. Go to the second floor, turn right at top of the stairs. Suite 209.
